- 7. Matters Arising
 - a) Planters in Sandon Sandon Estate Manager, Michael Eld is to seek approval to place a planter at either side of the bench on the green
 - b) Highways Councillor Hickey reported that there had been a Mobile speed camera on the A51 in Sandon. A meeting with Highways, the police and other relevant authorities should be arranged to discuss the speeding on A51
 - c) Gully clearing in the Parish a freedom of information request should be submitted to ascertain when gullies were last emptied and the stated frequency of this
 - d) SIDs Councillor Rosemary Wildblood proposed that these should now be purchased all agreed, with no initial speed survey
 - e) Further exploration into extending the 40mph speed limit to past the Burston turning
