There have been many changes over the last twelve months to Sandon and Burston Parish Council. We have welcomed our new clerk, Ginny Gibson, who received an excellent handover from our previous clerk, Nikki Evans; Councillor Rosemary Wildblood stood down as Chair after 3 years in post; Councillor Caroline Capjon and Kylie Paramanis gave up their roles as councillors and we welcomed three new councillors to the council, Councillor Patrick Hickey, who rejoins the council and Councillor Adam Greaves and Councillor Liann Barnett, both joining the council for the first time. I would like to say a big thank you to those who have left us and a warm welcome to the new councillors.

This last year has seen our main activity concentrating on two large issues, firstly the River Trent bridge in Burston, which was forced off its riverbank on the Aston side of the river by a fallen Willow tree in 2023. The council has been pressing the County Council to resolve the problem ever since it occurred and at last, we have been told that there is a budget in place to resolve the problem and that this will happen in 2025. The second concern has been the speed on A51. The council have proposed to provide 3 Speed Indicator Devices (SIDs) in Sandon to encourage drivers to maintain the 40mph speed limit. The battle to have the speed limit reduced on the A51 from Sandon to past Burston continues with, hopefully, some new arguments to be put forward to the relevant authorities in an attempt to make this very dangerous stretch of road safer for the local inhabitants and for all other road users.

There have been many other matters that the council have been involved in throughout the year, the clearing and cleaning of the footpath on the A51 from Burston to Sandon and Christmas Tree lights in both villages to mention just two of the more visible successes.
