

Sandon and Burston Parish Council Meeting Minutes

Minutes of a meeting held on Tuesday 3rd March 2026, at Sandon Parish Room, Lichfield Road, Sandon, Stafford ST18 0DN. The meeting commenced at 7pm.

Present: Cllr H Wildblood (Chairman), Cllr A Hudson, Cllr A Greaves, Cllr G Wyatt, Cllr Mynors (SCC), Cllr Aspin (SBC), Cllr O Antcliff, one member of the Public and the clerk.

26.03.001 APOLOGIES AND APPROVAL OF ABSENCES - Cllr Rosemary Wildblood - APPROVED

26.03.002 TO RECEIVE DECLARATIONS OF INTERESTS AND TO CONSIDER REQUESTS FOR DISPENSATIONS. - NONE

26.03.003 TO RESOLVE THAT THE MINUTES FOR THE MEETING HELD ON 13th January 2026 ARE A CORRECT RECORD. RESOLVED.

26.03.004 TO CONSIDER AND APPROVE CO-OPTION OF A PARISH COUNCILLOR.

Stafford Borough Council confirmed Council could co-opt a new Councillor. Advert on website from 20.01.2026.

Councillors considered an application received in confidence and asked Mr Owain Antcliff to give a 3 minute presentation to the meeting and Mr Owain Antcliff outlined his experience and interest in the Parish.

Council voted unanimously to accept the application and Mr Owain Antcliff signed the Acceptance of Office document, countersigned by Clerk (Proper Officer).

RESOLVED for Clerk to update website and inform Stafford Borough Council.

26.03.006 TO CONSIDER AND APPROVE IT POLICY

Councillors considered an IT Policy and RESOLVED to adopt it. Clerk to add to website.

26.03.007 TO CONSIDER QUOTATIONS FOR TWO NEW BENCHES FOR BURSTON POOL AND RECONSIDER QUOTE FOR REFURBISHMENT OF EXISTING BENCHES.

Council considered two quotes for new Benches and re-considered quote from SJS Home to refurbish existing benches. RESOLVED to accept refurbishment quote. Clerk to inform contractor.

Cllr Mynors (SCC) advised Council could apply for the Community Fund, opening in April to cover costs of refurbishment. RESOLVED for Clerk to apply.

26.03.008 TO CONSIDER AND APPROVE A COMMUNITY GRANT APPLICATION

Councillors considered the application received. Council RESOLVED to ask the community group to re-apply providing more detail regarding projects and funds required.

Councillors considered best way to engage with residents and RESOLVED to have a Parish Council stand at both Sandon Fete and Burston Tea Party in 2026.

RESOLVED to used event budget funds to create promotional material for stand.

SPEED INDICATOR SIGNS

Parish Council updated that SCC are reviewing their Speed Indicator Signs policy and will update the Council once the review has taken place. SCC advised new procedure for installation requires a Speed Survey for each proposed location (3 in Parish) at a cost of approx. £300 per survey. SCC will then review the survey and make recommendation about the locations. SCC provided historic speed survey data.

RESOLVED to NOT move forward with the current project and use Budgeted Funds for a future speed project. Clerk to Earmark Funds.

STATIC SPEED DEVICES (A51)

Clerk sent an email to Police asking if Safer Staffordshire had decided which devices will become digital and when – 22.01.2026

Safer Staffordshire Roads Partnership updated the Council – 29.01.2026:

“Plans for the next phase of camera upgrades have not yet been progressed, so I am unable to confirm whether the A51 through Sandon will be included. A review of camera sites is expected later this year.”

RESOLVED for Clerk to continue to liaise with Police and Safer Staffordshire to request Sandon 3 Static Cameras become digitalised.

CANAL BRIDGE WORKING GROUP REPORT – UPDATE

The Working Group met on 19th February and provided a report for Councillors to consider.

RESOLVED Frame of Reference to be amended, to remove retired Councillor and add Cllr Antcliff.

RESOLVED for all actions within the report to be carried out by Working Group.

RESOLVED for Clerk to send Highways Letter to Staffordshire County Council.

RESOLVED for Cllr Greaves to set up a Whatsapp Group (telephone numbers withheld) to liaise with Working Group members between meetings.

SCC advised works will start when ground is stable, possibly in March 2026, unable to open fencing around site due to health and safety – update on website 27.01.2026

Canal and River Trust confirmed they will replace the stile with a gate and put steps into the slope – works completed 03.03.2026. RESOLVED to send Thank you email to Canal and River Trust.
